4. Does the applicant understand the responsibility to instruct their employees that selling tobacco products to a minor is against the law? _____
5. Does the applicant understand that the actions of their employees may cause the applicant's business to be fined, suspended, or revoked due to a violation under the laws of the City of Golden, the State of Colorado, or the United States? _____

Does the applicant understand that the place of business will be subject to inspection for compliance with Chapter 4.96 of the City of Golden Municipal Code and may involve the use of minors under the supervision of law enforcement to ensure that the applicant's business is not selling tobacco to minors? _____

Applicant agrees to operate this business according to the law and that the rights and responsibilities conferred to the license, if granted, cannot be assigned to another.

Any lack of access to any portion of a licensed premise during inspection will be deemed a refusal to permit inspection. Such refusal is grounds for revocation of this license.
